Important Questions	Answers	Why This Matters:
What is the overall <a href="#">deductible</a> ?	<b>\$8,450</b> / individual or <b>\$16,900</b> / family in-network. <b>\$16,900</b> / individual or <b>\$33,800</b> / family out-of-network.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. In-network <a href="#">preventive services</a> , 3 illness-related office in-network visits, Tier 1 and Tier 2 drugs and some pediatric dental services are covered before you meet your <a href="#">deductible</a> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. Are there other <a href="#">deductibles</a> for specific services?	No.	You don't have to meet <a href="#">deductible</a> for specific services.
What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	For in-network <b>\$8,450</b> individual / <b>\$16,900</b> family.	The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services. If you have other family members in this <a href="#">plan</a> , they have to meet their own <a href="#">out-of-pocket limits</a> until the overall family <a href="#">out-of-pocket limits</a> has been met.
What is not included in the <a href="#">out-of-pocket limit</a> ?	All out-of-network <a href="#">cost sharing</a> amounts ( <a href="#">deductibles</a> , <a href="#">copays</a> and <a href="#">coinsurance</a> ), <a href="#">premiums</a> , <a href="#">balance-billing</a> charges, healthcare this <a href="#">plan</a> doesn't cover, and <a href="#">specialty drug</a> coupon programs payments.
